**4.1 Review and Possible Action on Fiscal Year 2024/25 Measure U Programming Grant Applications**

Mammoth Lakes Recreation (MLR) Program Director Kim Anaclerio and Chair Heather Schaubmayer outlined the information in the staff report.

Clean Up The Lake (CUTL) Founder and CEO Colin West provided background information on his career and organization, and discussed how he ended up coming to Mammoth to clean our lakes.

Friends of the Inyo People's Mural Project Project Curator Melle North provided additional information regarding her project.

Mammoth Channel Owner Dan McConnell provided additional information regarding his project.

Mammoth Ski Patrol Alumni Association Member Mike Kleinfelder provided additional information on their application and association.

Eastern Sierra Avalanche Center (ESAC) Administrative Manager Barb Bemis provided a program update, discussed last year's historic snowfall, and provided additional information about the ESAC organization.

Eastern Sierra Community Chorus (ESCC) Board Member Cindy Anderson provided a program update and additional information about ESCC and its events. ESCC Secretary and Board Member JoAnne Hein spoke about the free voluntary music class series *Demystifying Music Reading* that they were now offering for their chorus members.

Sierra Classic Theatre (SCT) Artistic Director Allison McDonell Page provided a program update, outlined the information in the SCT application, discussed upcoming events, and reported that SCT had filed a lawsuit against Brown Paper Tickets.

Friends of the Inyo (FOI) Stewardship Director Lindsay Butcher provided a program update and outlined the information in the FOI application.

Mono Arts Council (MAC) Executive Director Kristin Reese provided a program update and outlined the information in the MAC application.

Valentine Eastern Sierra Reserve (VESR) Director Carol Blanchette provided a program update and outlined the information in the VESR application.

**1. CALL TO ORDER**

The Chair called the meeting to order at 8:34 a.m. in the Council Chamber, 437 Old Mammoth Road, Mammoth Lakes.

Committee Member Tamara Bankson reported that she would attend the meeting remotely under the "Just Cause" provisions under Assembly Bill 2449 (AB 2449) for medical reasons.

**2. PUBLIC COMMENTS**

Chair Heather Schaubmayer thanked Mammoth Lakes Recreation Program Director Kim Anaclerio for her hard work and time spent on this endeavor, and thanked the applicants for their time and efforts. Ms. Schaubmayer provided a brief description of Measure U funding, and said that she was thankful for the opportunities it provided for our community.

### **3. POLICY MATTERS**

#### **3.1 Review and Possible Action on Fiscal Year 2024/25 Measure U Programming Grant Applications**

Chair Heather Schaubmayer outlined the process that would take place today and provided an opportunity for applicants who could not attend yesterday to speak today.

Eastern Sierra Symphony (ESS) Artistic Administrator Stephen Thiroux provided a progress report and outlined the information in the ESS application.

Mono Arts Council (MAC) Executive Director Kristin Reese provided additional information regarding the Friends of the Inyo (FOI) - The People's Mural Project application, and the budget that had been turned in by Project Curator Melle North last year for Special Project Measure U funding, which was allocated through MAC's application as a fiscal sponsor for the project, and how those funds had been spent. It was determined that an allocation recommendation this year would be contingent upon a new budget being submitted to Program Director Kim Anaclerio by March 4th at 5:00 p.m. strictly for the People's Mural Project, not a FOI budget, detailing how the funds would be used, as well as how the monies allocated previously had been used, and inclusion of an in-kind match.

Ms. North joined the meeting after the conversation about her application had taken place. Chair Schaubmayer provided her with direction on what needed to be provided in the way of a new budget and when it needed to be submitted.

There was discussion between the applicants, Program Director Kim Anaclerio and members of the Committee.

Approve the following recommendations be made to the Mammoth Lakes Recreation Board for Measure U funding: Clean Up the Lake \$12,000, Mammoth Mountain Ski Patrol Alumni \$6,750, Friends of the Inyo – People's Mural Project \$5,000 (contingent upon the Project Curator providing a revised budget to MLR Program Director Kim Anaclerio by 5:00 p.m. on March 4, 2024), Eastern Sierra Community Chorus \$8,500



per year for three years, Mammoth Channel \$7,000, Chamber Music Unbound \$32,000 per year for years two and three, Eastern Sierra Arts Alliance \$40,000 per year for years two and three, Eastern Sierra Symphony, \$15,500 per year for years two and three, Mono Arts Council \$34,000 per year for years two and three, Valentine Eastern Sierra Reserve \$10,000 per year for years two and three, Friends of the Inyo \$11,000, Eastern Sierra Avalanche Center \$11,500 per year for three years, and Sierra Classic Theater \$10,500 per year for three years.
