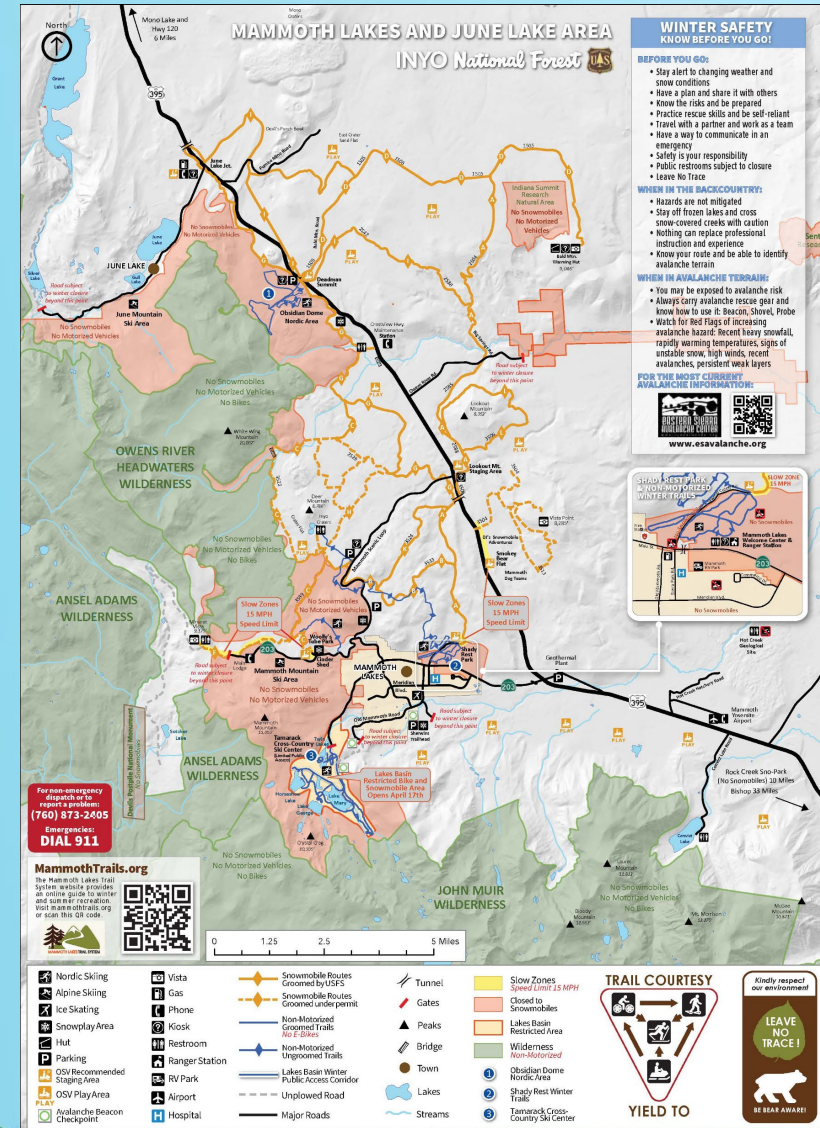

# OSV Grooming Program

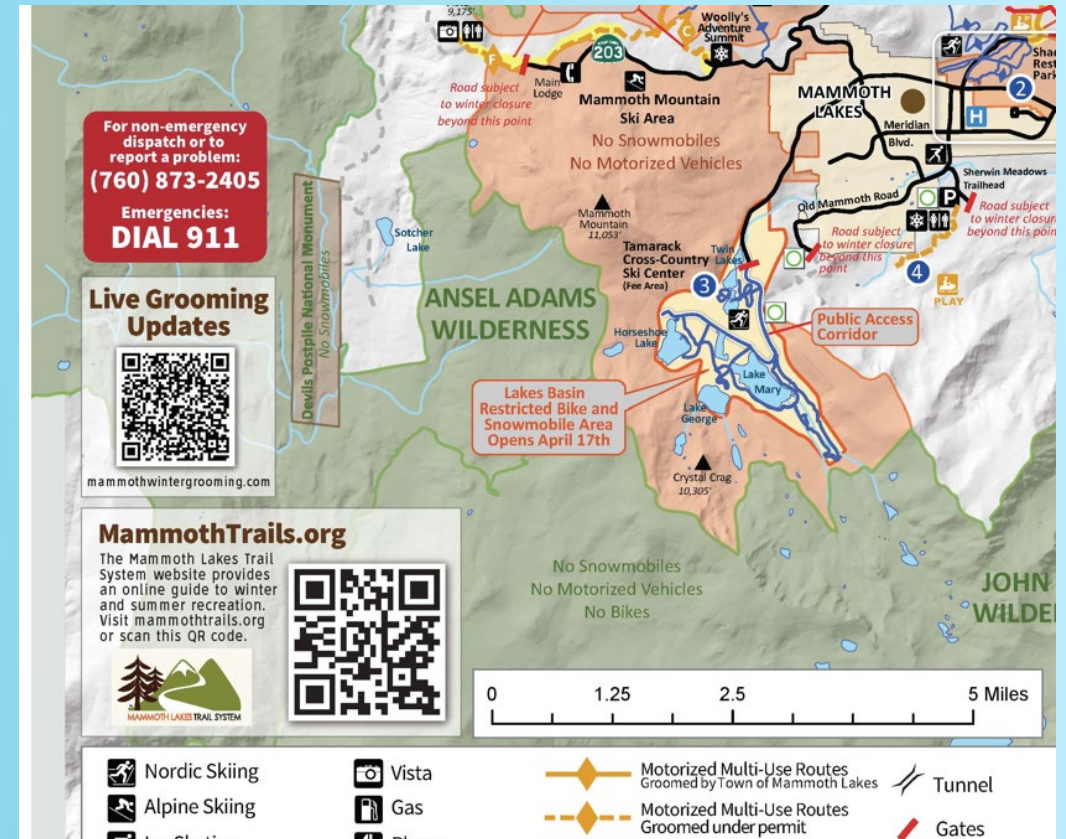
- Hired Jeff Smead – experienced cat operator

## **Background Information:**

The 2025 Parks & Recreation Department (PRD) Strategic Workplan was developed to strategically guide the Parks and Recreation Commission and Department in fulfilling the shared community vision and stated mission of the Parks and Recreation Department. The strategies for 2025 were aligned with the following Town Council adopted documents.

- A. Town Council Strategic Priorities and Key Objectives Statement – Updated March 5, 2025
- B. 2012 Parks and Recreation Master Plan

## **Strategic Initiatives (pillars)**

The four strategic pillars introduced in 2020 remain and are as important as ever in guiding our decision-making, strategic thinking, and aspirational and operations.

- 1. Excellence:** *We are committed to continually improve the delivery of our community programs and facilities by holding each other accountable to the high standards of excellence our departmental culture expects and demands.*
- 2. Teamwork:** *We value our employees and the power of a team culture aligned with a single vision and unifying purpose by communicating, connecting, collaborating, committing and celebrating with each other to achieve extraordinary results.*
- 3. Sustainability:** *We help to protect and preserve our natural, developed and finite resources by implementing sustainable best practices in our programs, parks, pools, fields and facilities.*

# Mammoth Lakes Recreation Commission Staff Report



The purpose of strategic planning is to provide clear direction by establishing high-level goals and measurable objectives for the department to achieve in a calendar year. A strategic plan provides a distinct and unifying direction for staff in guiding day-to-day decisions with a goal of maximizing resources (time, money, staff) while minimizing or eliminating ambiguity and distractions. Strategic planning is also a valuable tool for evaluating progress and a critical step in the department’s capacity and ability to meet the expanding recreation needs of the community.

The 2024 Strategic Workplan provided a blueprint for success by clearly identifying the strategy, goals, supporting tactics and in many cases, measurements for success. Staff’s goal is to continually refine the workplan by transitioning work items from the strategic workplan to our seasonal workplans when they become part of our daily operations.

## **Primary Areas of Focus**

The “Core Program Areas” introduced in 2022 continue to provide intentional focus for the department in developing and delivering scalable and sustainable recreation programs aligned with the resource capacity and capabilities of the Department. They are as follows:

- 1) Youth/Teen Camps and Programs
- 2) Community Recreation Center (CRC) Programs/Events
- 3) Adult Activities
- 4) Community Events/Activities
- 5) Facility Operations/Maintenance

Similar to program areas of focus are the core deliverables for the Department. These are work items that were prioritized for implementation, consume the majority of resources, and ultimately, helped define success for the Department.

- A. Programming of the year-round Community Recreation Center (CRC)
- B. Delivery of Core Program Areas
- C. Building Team Capacity

## 2025 Strategic Workplan Review

The current strategies and associated goals have been critical in providing clear direction for the delivery of the department’s vision and mission. The plan has also been beneficial in guiding the Commission’s interaction and engagement with Mammoth Lakes Recreation, the community, and Town Council as it pertains to the powers and duties of the Parks and Recreation Commission ([Chapter 2.36](#) of the Town’s Municipal Code).

On December 3, 2024, staff highlighted the achievements and outcomes of the 2024 Strategic Priorities and Key Objectives. Since that time, staff further refined the number of strategic priorities to a total of three. In addition, staff incorporated the most recent version of the 2025 Town Council Key Objectives adopted on March 5, 2025. Relevant objectives to the Parks and Recreation Department are the following:

- Community Recreation: Enhance access, availability and affordability of Parks and Recreation amenities, programs and services.
- Town-wide Vision, Plans and Services: Conduct a comprehensive review and prioritization of all Town plans and implementation efforts.
- Community Engagement: Increase community engagement and outreach efforts, including a focus on Spanish-language offerings and Latino community engagement.
- Environmental Sustainability: Reduce our impact on the natural environment.
- Capital Projects: Continue to evaluate and implement the Town’s Capital Improvement Program (CIP).

## Core Strategies

The three core strategies for 2025 have been refined and are as follows:

- A. Invest in the Town’s Recreation Infrastructure**
- B. Deliver High-Quality, Affordable and Sustainable Recreation Programming**
- C. Build Capacity to Enhance and Expand Programming**

The objectives were also enhanced and were aligned with the SMART Acronym.

## **Staff Recommendations:**

Receive an update on the development of a new Parks and Recreation Master Plan and provide consensus comments to staff.

## **Background Information:**

At the regular meeting of the Parks and Recreation Commission on April 2, 2024, staff presented a summary and update of recommended tasks, programs and proposed recreation amenities as outlined in the Parks and Recreation Master Plan published in 2008 and adopted by Town Council on February 1, 2012. The Plan outlined the vision, goals, and tasks for enhancing parks and recreation for Mammoth Lakes through 2025.

At that time, Town staff recommended the development of a new Parks and Recreation Master Plan that included updated goals and policies, an analysis of the supply, demand and needs for park and recreation facilities and services within and surrounding the Town of Mammoth Lakes and an action plan with conceptual site plans that articulate a clear vision and “roadmap” over the next 10-15 years or longer.

This recommendation was affirmed by the Commission and since that time, staff have been working to develop a scope of work (Request for Proposals document) and implementation plan, including a funding estimate and path forward for Town Council consideration.

Staff have provided regular updates to the Commission regarding the process and after the adoption of the 2025 Town Council Strategic Priorities on March 5, 2025, that incorporated the stated Municipal Services objective of “...conducting a comprehensive review and prioritization of all Town plans and implementation efforts...”, staff have prepared an implementation plan for the Commission’s consideration and review.

On March 19, 2025, Town Council allocated \$300,000 for the implementation of the PRMP.

## **Analysis And Discussion:**

The Parks and Recreation Master Plan (PRMP) published in 2008 and adopted in 2012, is reaching the end of its relevancy and community-driven list of identified tasks and recommendations through 2025. Based on several public meetings, previous facility needs assessments (2001), and a comprehensive Parks and Recreation Needs Assessment Survey conducted in 2007, the plan presented six goals, provided specific level of service recommendations, and identified five primary tasks. The tasks were as follows:

- A. Maintain and upgrade existing parks and recreation facilities to improve accessibility, usability, and service capacity.
- B. Complete construction of recreation-related projects already underway.
- C. Expand partnerships with public agencies, private organizations, and businesses to share resources in providing facilities and programs.
- D. Design additional park improvements and recreation facilities to meet recreation needs in all seasons
- E. Ensure that the Town's parks and recreation facilities will become part of an integrated system that encompasses parks, activity centers, trails, and access to public lands around Mammoth Lakes.

Tremendous progress has been made delivering on the recreational needs and expectations of the community these past 16 years. The majority of these goals and tasks have been completed, with some underway, and others that require further analysis, funding and appropriate sites for development. The values expressed in the PRMP continue to be relevant, along with the vision and framework to serve the recreation needs of Mammoth Lakes' residents and visitors. However, the stated goals, level of service recommendations, and primary tasks need to be realigned and reimagined to provide the necessary framework to meet the ever changing and evolving recreation needs and expectations of the community, second homeowners, seasonal workers, and visitors to Mammoth Lakes.

## **Implementation Plan**

The Parks and Recreation Master Plan will be a guiding document for future development and redevelopment of the Town's system of parks, facilities, and recreation programs and services over the next 10-15 years. The plan will define goals, tasks and prioritized strategies and program and amenity recommendations based on current and future funding, land use and level of service scenarios and standards.

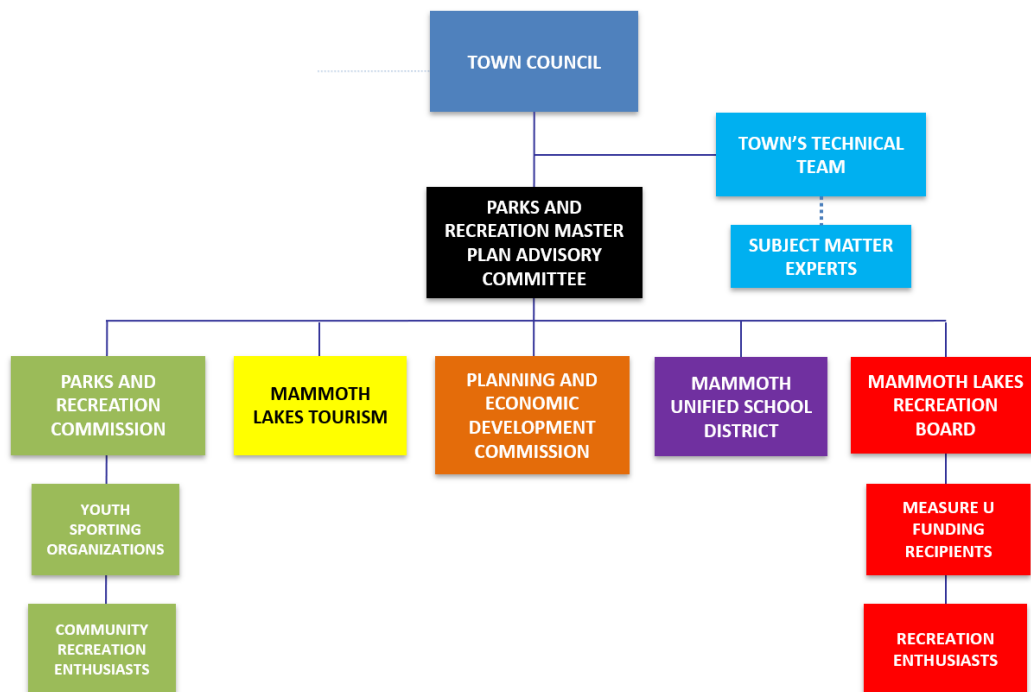
A comprehensive master plan is expected to take 12-18+ months, depending on the desired outcomes and defined deliverables. There are several phases and tasks required to begin the process to update the Parks and Recreation Master Plan (PRMP) that are outlined below. Prior to the selection of the consultant and finalization of the PRMP outcomes and deliverables, the phases below should be used only as a guide in the process to inform planning efforts.

### ***Phase 1 – Preparation Phase (March – May 2025)***

- 1. Establishment of the Town's Technical Team
  - a. Composition: Parks and Recreation Director, Public Works Director and Community and Economic Development Director.
  - b. Purpose: Manage the development of the PRMP.
  - c. Responsibilities:
    - i. Manage the RFP process, including the selection of the consultant.
    - ii. Support and staff the PRMP Advisory Committee.
    - iii. Provide technical expertise and coordinate the addition of subject matter experts as needed to support the development of the PRMP.
    - iv. Provide general oversight, expertise and guidance to the consultant.

- v. Support the Parks and Recreation Director as needed in the delivery of the PRMP.
2. Mammoth Lakes Recreation (MLR) board (3/18) and Parks and Recreation Commission (4/1) presentation of the DRAFT PRMP Development Plan. Includes the proposed timeline, desired outcomes and deliverables, and the proposed formation, composition and purpose of the PRMP Advisory Committee.
  3. Town Council presentation and approval of the PRMP Implementation Plan (4/19), including the desired outcomes and defined deliverables, and direction to form a Brown Act PRMP Advisory Committee who will function as the Town Council’s advisory body for the development of the Parks and Recreation Master Plan.
  4. Formation of the PRMP Advisory Committee
    - a. The composition of the committee is as follows and its relationship with the Town Council is illustrated below in the organizational chart.
      - i. 1 x Town Councilmember + alternate (4/16)
      - ii. 1 x Parks and Recreation Commissioner + alternate (6/3)
      - iii. 1 x Mammoth Lakes Recreation Board member + alternate (5/13)
      - iv. 1 x Planning and Economic Development Commissioner + alternate (5/14)
      - v. 1 x Mammoth Unified School District representative + alternate (TBD)
      - vi. 1 x Mammoth Lakes Tourism representative + alternate (5/21)
      - vii. 3 x Community at Large representatives (application process – selected by Town’s Technical Team.



- b. Purpose: Town Council Advisory for the development, review and implementation of the PRMP’s stated outcomes and deliverables.

- c. Responsibilities:
  - i. Provide general input, guidance and communicate their affiliated organizations recreation interests to the consultant and the Town's Technical Team.
  - ii. Participate in regular (quarterly) progress reports scheduled by the Town's Technical Team. Inform their respective organizations as well as provide consensus input/recommendations from their respective organizations to the consultant.
  - iii. As needed, support the consultant and Town's Technical Team in the development of the PRMP development plan (i.e. community engagement tactics, public outreach, venue locations, etc.)

## ***Phase 2 – Consultant Appointment (June 2025 – August 2025)***

1. Publication and distribution of the Request for Proposals (RFP) document for the development of the Town of Mammoth Lakes Parks and Recreation Master Plan.
  - a. Plan to publish on April 25 with selection in June by the Town's Technical Team.
2. Town Council selection (8/6) of consultant/firm and allocation of additional funding (if necessary) to develop, manage and deliver the new Parks and Recreation Master Plan.
3. Kick off meeting with consultant and introduction of dedicated Consultant Project Team to the Town's Technical Team, PRMP Advisory Committee and the Town Council. The consultant will present an overview of the process, timeline and how it will develop a clear set of goals, tasks and level of service standards for the community's park system, green space, trails, recreation facilities and program development for the next 10-15 years, if not longer.

## ***Phase 3 – Community Engagement, Data Collection and Plan Development (Sept. 2025 – Summer 2026)***

1. Consultant conducts a review of previous documents, an inventory analysis that considers the fair and equitable quantity, distribution, inclusivity, condition, cultural relevancy, connections and proximity of parks, green space, programs, recreation centers and services.
2. Consultant presents the project website and communication channels utilized for community outreach, engagement and information sharing.
3. Consultant presents the community engagement plan, tactics (activities, techniques and formats), strategies and methodology to achieve equitable, inclusive and broad community participation in the PRMP planning process.

4. Consultant presents recommendations for the review of the vision and mission statements, department goals and tasks. Includes a summary of gaps in services and/or amenities identified from extensive public outreach and the needs assessment survey.
5. Consultant presents DRAFT PRMP Master Plan that includes the following elements:
  - a. Written goals, (new vision/mission statements if necessary), tasks, and recommended new/redeveloped recreation services and facilities.
  - b. Financial action plan that includes an asset management plan addressing planned maintenance and on-going investment for existing and future amenities (including conceptual site plans).
  - c. Develop conceptual site plans for the following:
    - i. Whitmore Recreation Area
    - ii. Bell Shaped Parcel
    - iii. Community Center Park
  - d. Summary of existing conditions, inventories and utilization metrics, population demographics and outcome metrics. Includes charts, graphs, maps and other data as needed.
  - e. Presentation of Level of Service standards for the life of the plan (approx. 15-20 years. Should include year-round residents, second homeowners, and seasonal worker populations.
6. Environmental review (CEQA) of the draft Parks and Recreation Master Plan.

### ***Phase 4 – Approval and Public Presentation Phase (Fall 2026)***

1. Town Council approval of a Resolution for a General Plan amendment adopting the Parks and Recreation Master Plan and amending the Parks, Recreation, and Open Space Element of the Town’s General Plan.
2. Consultant presents the new Parks and Recreation Master Plan to the public, the Parks and Recreation Commission, Mammoth Lakes Recreation board and the Planning and Economic Development Commission.

### ***Phase 5 – Implementation Phase (Fall/Winter 2026/27)***

1. Town’s Technical Team drafts and presents Implementation Plan to PRMP Advisory Committee and Town Council for review and approval.
2. Town’s Technical Team and assigned staff begin implementation of the community-driven and validated goals, tasks and plan objectives, including the revision of the Capital Improvement Plan (CIP) as necessary.

***Parent/Child: (6 month - 2 years)***

This class is designed to introduce babies and young children to the water in an environment that encourages social interaction and fun. The instructor helps the parent by giving instructions and assisting the parent working with the child. This is **not** a “water proofing” class. The following skills will be introduced: water entry, blowing bubbles, prone glide, kicking, arm movement, and water exits.

***Tiny Tots (3-4 yrs.) – max. 3 participants per instructor***

This is an important class for allowing the child to become more comfortable in the water and with their instructor. This class introduces basic water skills such as kicking, blowing bubbles, front and back floats, and submersion.

***Level 1: Beginner-Introduction to Water Skills – max. 3 participants per instructor***

In this class the following skills will be taught and must be achieved before passing the class: front float and recovery, back glide and recovery, survival (back) float, beginner stroke, jumping in and leveling off, rolling from front to back and back to front, and personal safety skills.

***Level 2: Advanced Beginner Fundamental Aquatic Skills – max. 5 participants per instructor***

The following skills will be taught and must be achieved before passing the class: bobbing, independent survival float (front and back), independently rolling from front to back and back to front, front crawl, backstroke, treading water, underwater swimming, and beginning breaststroke. Skills learned in Level 1 will be improved in Level 2.

***Level 3: Intermediate- Stroke Development – max. 5 participants per instructor***

This class is for stronger swimmers. Proper techniques will be learned for front crawl, back crawl, breaststroke and beginning butterfly. The following skills will be introduced and developed: intermediate breaststroke, surface dives, dolphin kick, butterfly stroke, treading water, and diving.

***Level 4: Advanced- Stroke Improvement – max. 5 participants***

In this class, swimmers will work on building endurance and refining their strokes: front crawl, backstroke, breaststroke, and butterfly. Swimmers will learn and work on wall starts, block starts, and flip turns.

Should this occur more than once during a session/program, the class may be rescheduled.

**Cancellation/Rescheduling Policy:** All swim lessons are filled on a first-come, first-served basis. Swim lessons are closed when maximum enrollment is met. The Parks and Recreation Department reserves the right to cancel or postpone any activity due to inclement weather or low enrollment. A full refund will be made if the Parks and Recreation Department cancels an activity. A \$40 service fee will be imposed for all returned checks and could result in refusal of future participation. All participant cancellations received more than 14 days prior to the start of the activity will receive a refund, less a 10% processing fee. **Complete Phase II “Interior Improvements” of the Community Recreation Center (CRC)**

**Community Recreation Center (CRC) – PR 1 & PR 2**

- Phase II Tenant Improvements bid was awarded on October 2, 2024 to Lehman Construction.
- On March 19, 2024, the Town Council allocated \$280,000 to complete Phase II construction and awarded \$530,400 for Phase II enhancements.

**CRC Phase II Project Close-out and Facility Enhancement Update:**

Phase II construction is underway and progressing slowly and methodically. A majority of the items have been completed, with many on-going, while others have been impacted by poor workmanship from the previous contractor or delayed due to unforeseen circumstances. Completed items include the mechanical enclosure roofing, parking lot lights, facility-wide flooring, exterior pergola, upper locker room decking and access improvements for elevated viewing, bleacher purchase and installation and sound mitigation for the chiller. On-going work items include the installation of the modular staff offices & furniture (DIRTT & PIVOT Contract), scheduled to be installed this spring when the facility closes for the winter. Office work also includes electrical, HVAC and fire sprinkler connections to the offices, including the installation of the office T-bar ceilings. The stairs for the bleachers and ADA lift are in production and once on-site, will be installed. During this period of time, there has been several items that required a change in scope, such as the concession area, pergola sign lettering, safety netting and enhanced plexiglass player/scorer table screens, and the use of laminated glass for the railing to name a few. As such, an existing funding gap of \$280,000 remains to complete Phase II construction.

Town staff are also requesting several facility enhancements identified from Phase II that will significantly improve the operations, aesthetics and efficiency of the Community Recreation Center (CRC) for year-round use. These items are listed in detail below with a funding estimate of \$510,000.

## **GUEST SERVICE/RENTAL COUNTER**

The proposed guest service/rental counter in the north lobby is a scaled down version of the original design that incorporated office space for staff, a rentals area and a dedicated concession area for food and beverage sales. The original design was removed from Phase I to bring the project within budget based on the funds allocated by the Town Council for the construction of the facility. This proposed version is similar in design to the original version and integrates with the soon to be installed DIRTT office area located adjacent to the counter area and better serves and enhances the needs of staff, while providing greater public space and a heightened guest experience versus the original design.

The counter area includes custom designed case work, movable shelves, several drawers and durable counter tops that will incorporate point of sale systems, ADA access and a flip shelf for access. Toe kick heaters for staff will be installed (max. winter temperature inside facility is 45 degrees) and a prominent overhead store front will enhance the guest experience with elevated signage creating improved wayfinding and an improved sense of arrival for the public. HMC estimated the cost at \$152,000, based on the actual cost of work currently being undertaken by the contractor.

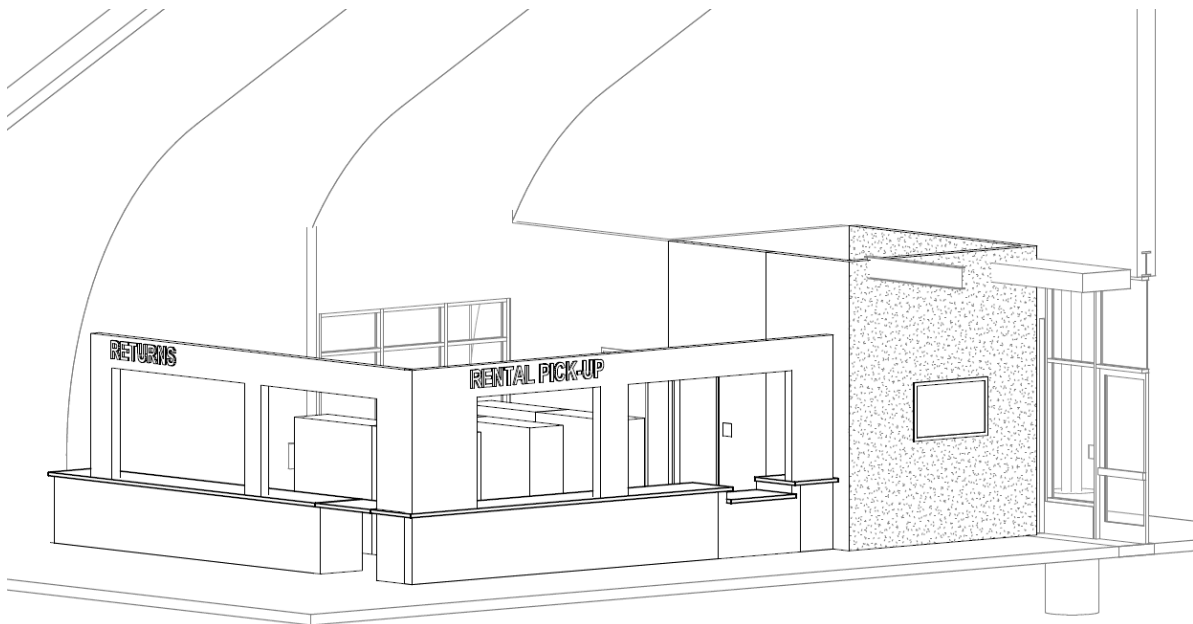


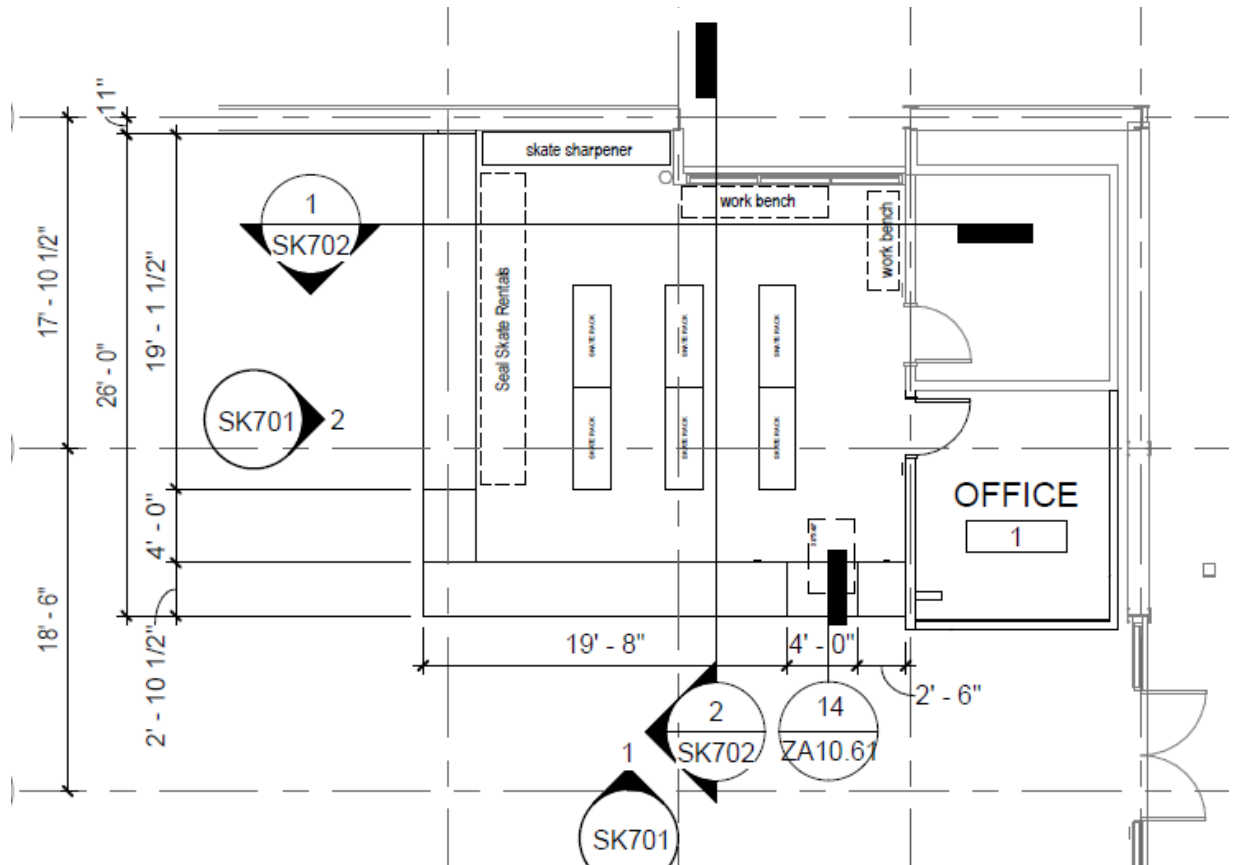

## **FACILITY SOUND ENHANCEMENT**

After operating for the past 18 months, it is apparent that the specified and budgeted sound system does not meet the needs of the facility or expectations of our many users. The sound system is barely adequate for the rink area and is severely limited by the glass and dasher boards that surround the rink and restricts the amplification of quality sound into and throughout the north and south lobby areas. As a short-term fix, the Town borrowed subwoofers and additional speakers placing them above the locker rooms, but with the installation of the new bleachers, this area is no longer available or suitable for these speakers.

This past month, the Town solicited assistance from an audio engineer from Daktronics and Brian Knowles from Eastern Sierra Audio who evaluated the facility and recommended equipment that will both augment the existing system and enhance high speech intelligibility and quality music reproduction throughout the facility. The enhancements will also enable control of the speakers in the rink/reczone area with a separate control for the speakers in the north and south lobby areas. The estimated cost for equipment and installation is \$42,000.

Design work is underway with an estimate of \$10,000 to construct the sign. Staff will install the sign and place solar lights for illumination at night.

Placement of Mammoth RecZone Sign is illustrated below:

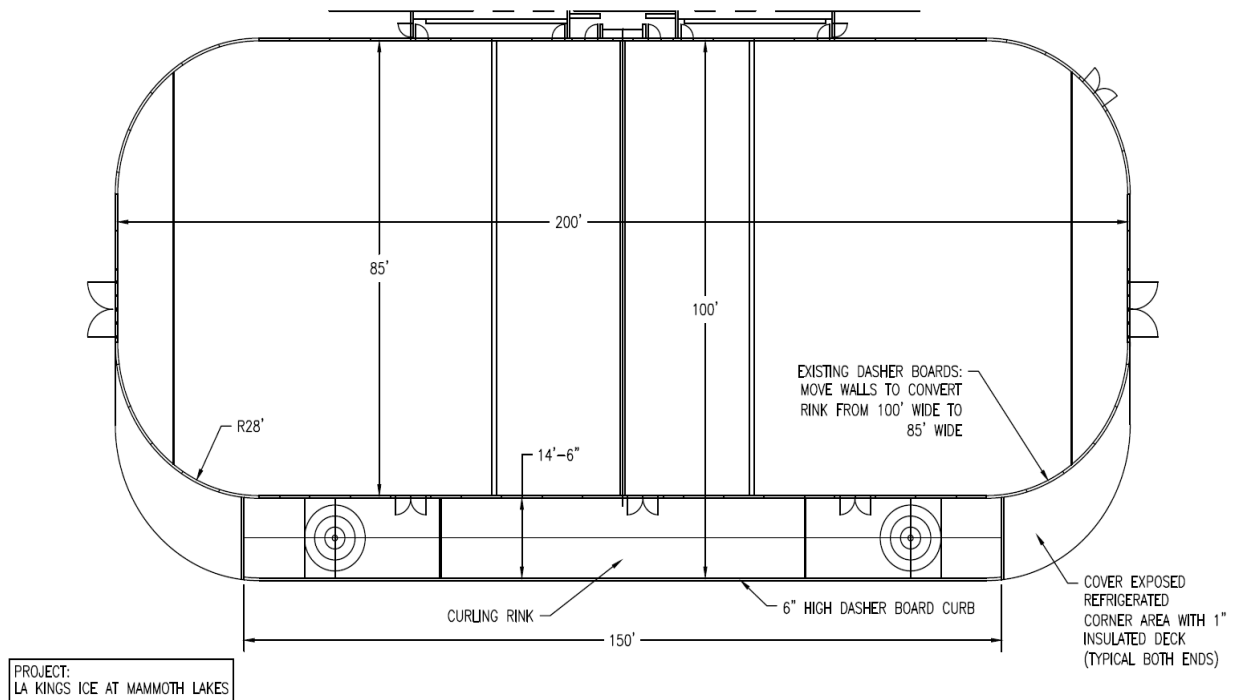


## **OLYMPIC-NHL RINK CONVERSION / DEDICATED CURLING SHEET**

---

The purpose of the conversion of the ice rink in winter from Olympic size (100'x200') to a smaller NHL size (85'x100') is to maximize the use of our one sheet of ice and increase programming opportunities for all user groups. In our second year of operations, we are experiencing a significant increase and growth in all ice sport categories. This includes public skate, youth and adult ice hockey, skate lessons, ice rentals and curling.

A layout of the rink conversion is illustrated below.



Most ice rinks in their third season would look to build another ice sheet but we don't have this option. We can, however, accommodate increasing demand for ice time by converting one large sheet of ice into two sheets of ice. The smaller ice sheet (15'x150') would create a dedicated curling sheet allowing for the significant growth of curling in Mammoth Lakes. Currently, due to competing demands for ice time, league curling can only be programmed on Sunday night with drop-in curling scheduled on Monday at lunch-time, with Community Curling nights scheduled once every month on Wednesday evening. The dedicated curling sheet would be programmed and available for use during the CRC's operating hours, simultaneously with other uses programmed on the skating sheet, greatly adding to the growth and interest in curling. For example, we could significantly increase the leagues from 13 teams to up to 20 teams based on a dedicated curling sheet. There is also interest in starting a Mammoth Lakes Curling Club, which would greatly benefit the community, as programming, leagues, lessons and tournaments would be facilitated by the club, with support from the Town.

The NHL regulation rink, similar in size to the old outdoor ice rink, would still be able to accommodate public skate, and lessons, but would significantly enhance the hockey experience for all ages as the majority of USA Hockey games, including the Olympics, are now played on NHL sized rinks. In addition, the LA Kings have expressed interest in utilizing the facility for pre-season training in September which would require an NHL rink.

The one-time cost for the rink conversion material is \$52,000, with a one-time labor cost of \$23,000 to convert the rink from Olympic size to NHL size. Town Staff will manage the conversion of the rink back to an Olympic size in summer for the installation of the Sport Court and convert the rink back to NHL in September for winter operations.

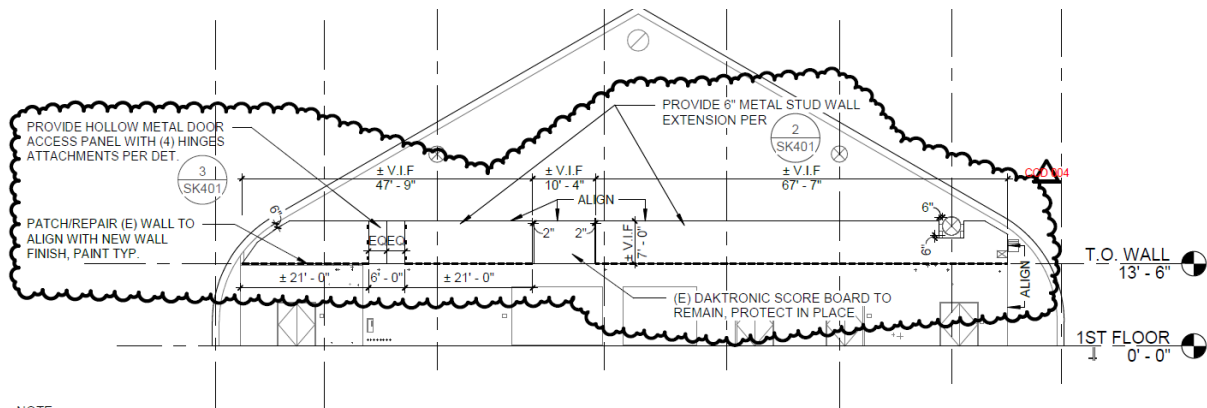


## WEST WALL SCREEN

This project satisfies several concerns and needs of the facility. The first is to maximize the available “second-floor” storage space above the west end Zamboni, storage, mechanical and electrical rooms by installing a 7-foot high wall screen to block the guests’ view of the mechanical equipment. The addition of an access door provides the opportunity to store seasonal equipment on this large 20’ x 120’ elevated space.

The second benefit is the ability to hang Mammoth Lakes Youth Hockey and Bishop High School hockey tournament banners on the wall showcasing their success and growth of our local teams.

Finally, the large scoreboard will be integrated into the west wall screen providing a higher quality and more visually appealing aesthetic for the facility and thousands of users. Funding estimate from the contractor is \$61,000.

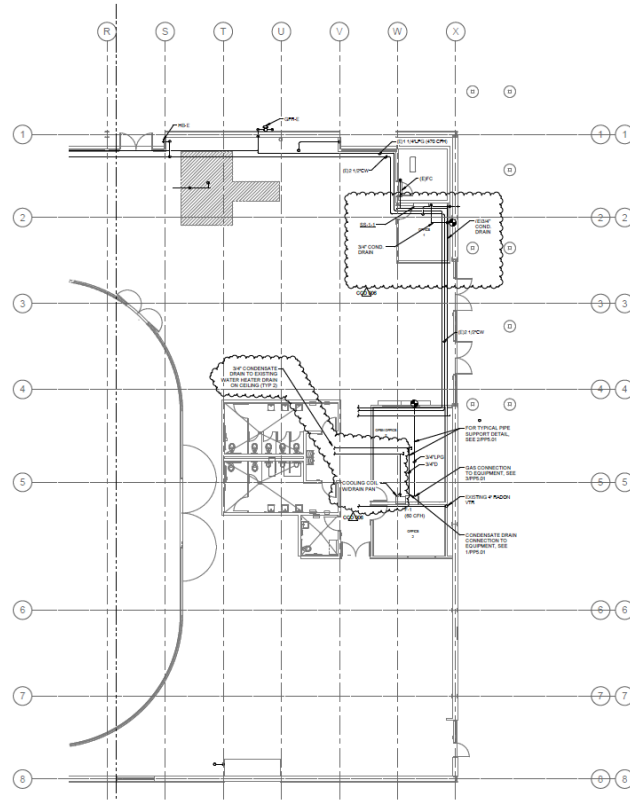
West Wall Elevation - Parapet Wall Extension

## STAFF OFFICE AIR CONDITIONING

The existing design and installation of the DIRTT offices for staff in the facility were specified with heating, but without air conditioning. Staff are correcting this oversight and are requesting funding in the amount of \$20,000 to install split A/C systems in the smaller operations office (adjacent to the Data room) and for the larger Parks and Recreation Department counter and supervisor/manager office space (adjacent to the lobby restrooms).



## HMC ARCHITECT ADDITIONAL DESIGN SERVICES

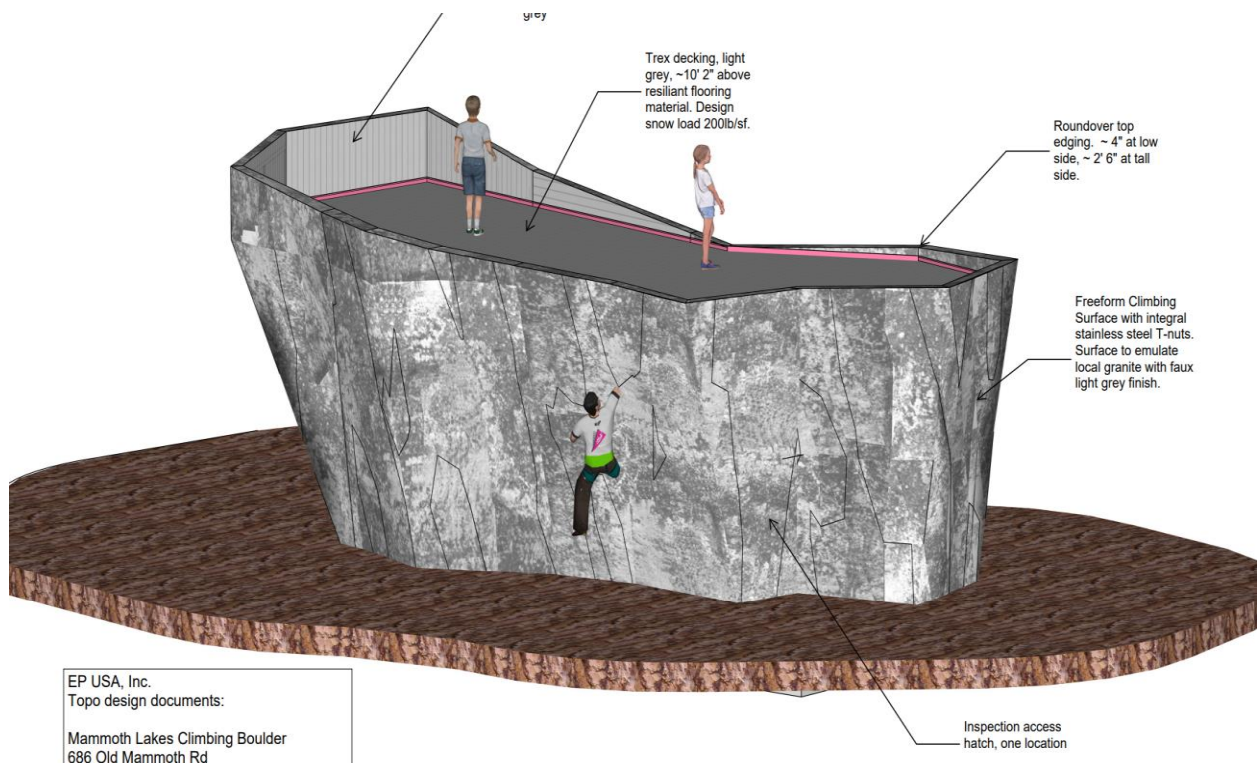
The current agreement with HMC Architects covers previously authorized scope of work and would need to be updated to include design and construction administration support services for the additional scope items contemplated in this staff report. Staff are recommending a \$152,000 set aside for architectural design services.

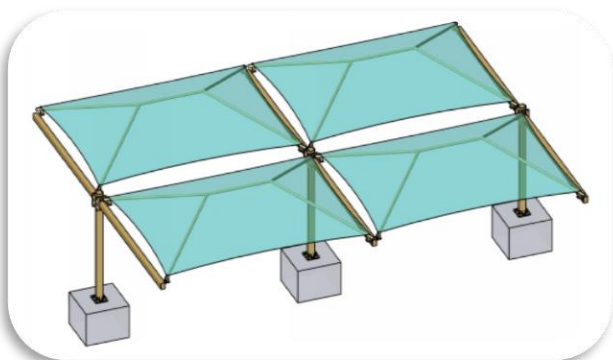
- Community Dog Park
  - Town Council officially opened the park on November. 6, 2024
  - Park Reopened for the winter in January and was closed later in Feb/March due to snow.

- On March 19, 2025, Town Council formally accepted the close-out report and finding shortfall for the dog park.
- At the time of the contract award, the project was fully funded with General Fund contributions of \$850,000 and a contribution of \$50,000 from a T-Mobile parks grant awarded to the Town, and an allocation from Capital Reserves Fund 980 in the amount of \$250,356.53, for a total funding allocation of \$1,150,356.53. An additional \$11,257.37 was needed to fully fund and close out this project. The overage is attributed to the purchase of wildlife proof trash containers, leach posts and minor electrical work that were billed to the construction project after the project was substantially complete.
- Park at the Parcel
  - The majority of the park is complete. Recent construction includes the 20'x20' pavilion, bike racks, and water fountain.
  - The park officially opened to the public on August 7, 2025.
- MACC/Edison Theatre and Outdoor Amphitheater
  - The Edison Hall is closed for renovations and will reopen this spring after water damage is remediated.
  - Staff and HMC are finalizing construction drawings for the MACC with bid documents planned to be published in Spring.
- Bike Park/Pump track
  - Town is finalizing Purchase and Sale Agreement of property with MLF
  - Funding is not secured for this project.
  - Identified in Town's 5-year CIP
  - Parks and Recreation is planning to install a small beginner pump track at the CRC to support summer camp operations.
- Mammoth Creek Park West Park Rehabilitation Project
  - The scope of work for the project is included below and is estimated at \$850,000.
    - Prefabricated Boulder purchase and installation
    - Shade structures
    - Synthetic turf
    - Grass lawn area
    - CRC railing
    - Park identification sign
    - Bike racks
    - Landscaping
    - Hardscape
    - Safety surfacing
    - Park Amenities
  - On March 18, 2025, Mammoth Lakes Recreation by motion approved the funding request of \$350,000 for the large, prefabricated custom boulder to be installed at the north/east corner of the park.

- The Mammoth Lakes Outdoor Freeform Climbing Boulder is designed and built by EP Climbing and will encompass 1,117 square feet of climbing surface to maximize t-nut placement and hand-hold route setting.
- The top profile varies from 11 feet to 13 feet 6 inches.
- Length is 32 feet, 8 inches with a width of 16 feet 3 inches.
- Top deck is Trex (light grey) and approx. 425 square feet, and surface emulates local granite color.
- Boulder will have a natural built in down-climb route, four (4) natural built in climbing routes and natural looking climbable crack seams.
- Integral steel support frame with weather resistant finish.
- The boulder is scheduled to be installed this spring.

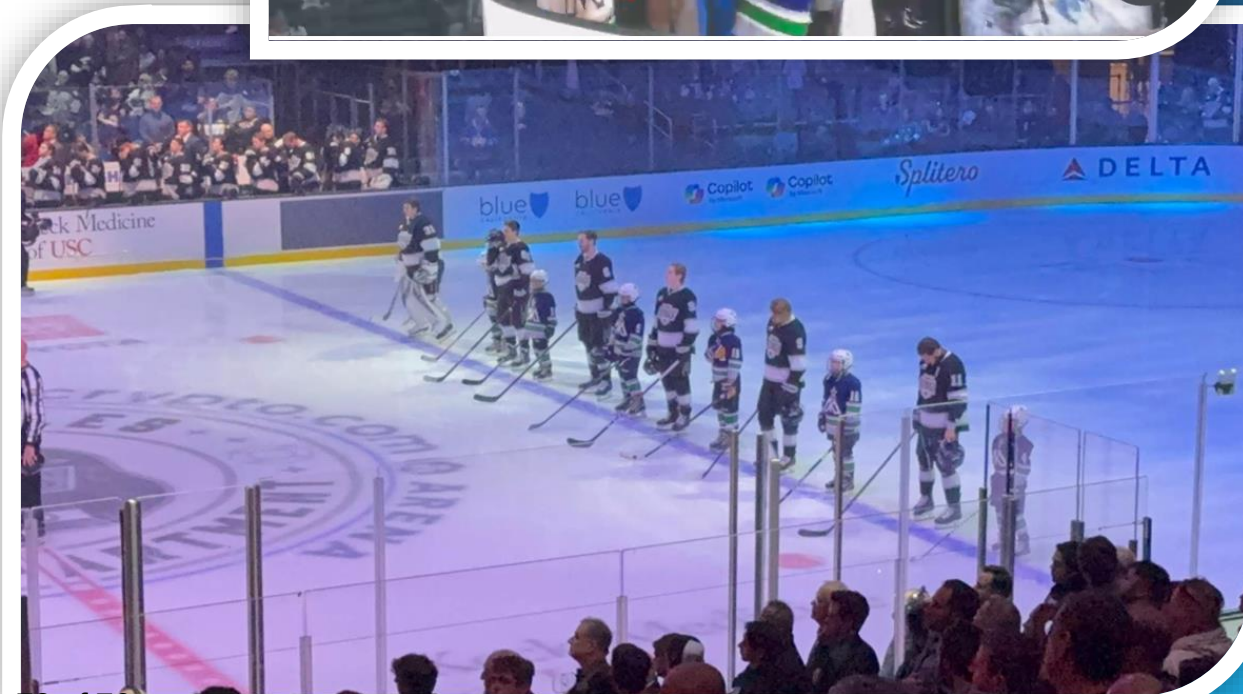
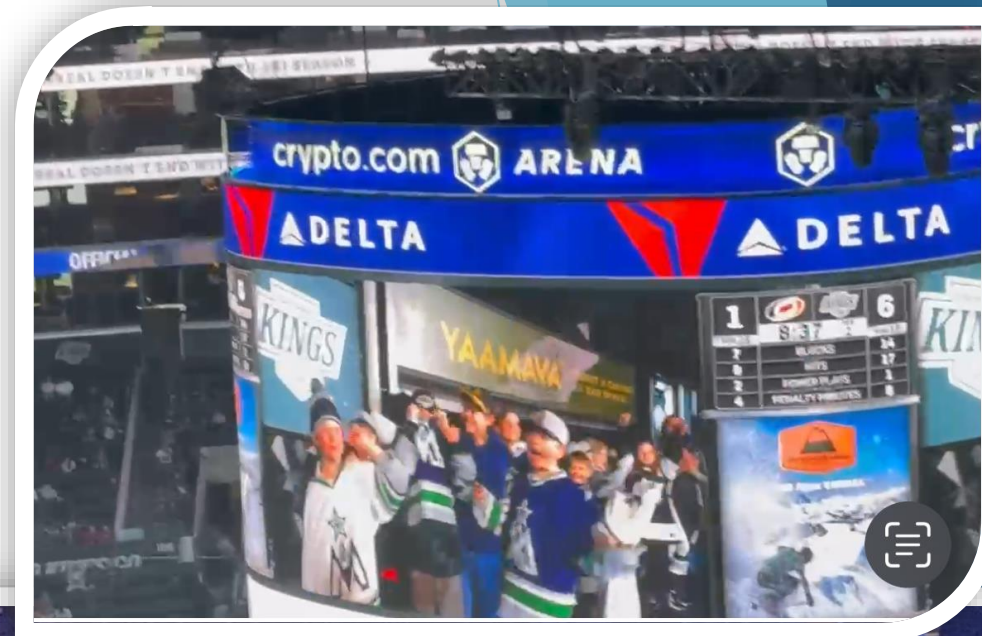

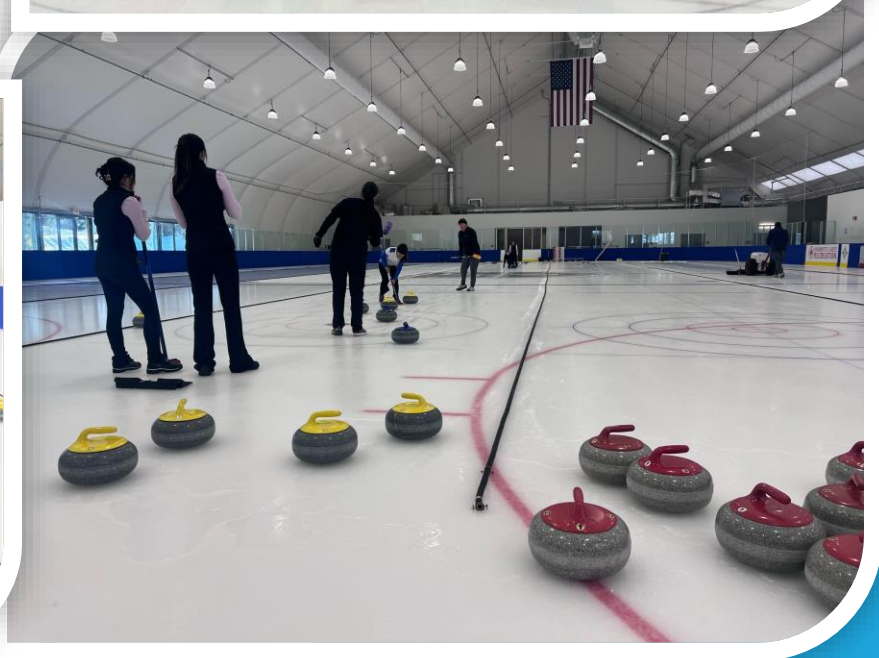
