RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MAMMOTH LAKES, STATE OF CALIFORNIA, APPROVING ALLOCATIONS FUNDING FOR PROGRAMS AND PROJECTS FROM THE FISCAL YEAR 20-21 BUDGET FROM MEASURE U (FUND 217)

WHEREAS, the Town Council approved in March 2010 the Utility Users Tax extension at the rate of 2.5% and the tax is a special tax, the use of which is restricted for the funding, planning, construction, operation, maintenance, programming, and administration of facilities and projects for Mobility, Recreation, and Arts & Culture, and is commonly referred to as "Measure U"; and

WHEREAS, Mammoth Lakes Recreation has reviewed, evaluated, and presented recommendations to the Town Council for the expenditure of Measure U funds; and

WHEREAS, the Town Council has reviewed the recommendations; and

WHEREAS, the approval of the recommended support for specific Arts & Culture programs requires Town Council approval to enter into funding agreements; and

WHEREAS, adequate funds are available for these purposes.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Mammoth Lakes as follows:

- 1) The above recitals are true and correct.
- 2) Funding for Arts and Culture Programs from Measure U (Fund 217) from appropriated funds for the following programs is hereby approved:
