Project Title: Engineering Support for Mammoth Main Lodge Redevelopment Entitlement Process

A. PROJECT DESCRIPTION AND BACKGROUND INFORMATION

In 2019, approximately 35.7 acres of land was transferred from the United States Forest Service to Mammoth Main Lodge Redevelopment LLC (MMLR). The land is currently located within the municipal boundary limits of the Town of Mammoth Lakes (Town). In January 2021, MMLR submitted a Pre-Application to the Town that included a conceptual land use plan and project description. The project includes two hotels, for-sale residential, club amenities, retail, dining, and skier services.

Two staff members within the public works engineering department are conflicted out of this project, and therefore staff needs additional engineering resources to ensure that the Town has experienced engineering representation throughout the process. We are looking for experienced consultant to provide engineering support during the entitlement phase of Mammoth Main Lodge Redevelopment.

B. SCOPE OF SERVICES

The scope of work focuses on the Mammoth Main Lodge Redevelopment LLC entitlement process. Tasks will be given to the consultant on an as needed basis and paid for as time and materials. Direction will be given to the Consultant in writing prior to them performing work. Tasks will include, but not be limited to, the following:

- Attend biweekly team meetings.
- Attend staff meetings as needed.
- Occasionally prepare material and present at Town Council meetings.
- Act as the Town Engineer, by answering questions and providing guidance.
- Review and comment on the EIR/EIS environmental documents.
- Look for consistency while reviewing environmental documents, proposed maps, and project description.
- Participate in negotiations regarding State Route 203 in the project area.

- Be familiar with current Caltrans rights-of-way and road conditions.
- Discuss future road projects with Town staff to get an all-inclusive view of future projects that may impact the Main Lodge Redevelopment project. For example, staff has recently met with Caltrans to discuss a potential Caltrans project along the entire stretch of SR 203.
- Provide information related to the benefits and drawbacks of the Town's involvement in the ultimate control of SR 203.
- Consider various road alignments and rights-of-way ownership dynamics.
- Ensure that conversations of maintenance agreements and fundings structures protect the interest of the Town.
- Consider entire roadway length when addressing overall traffic movements and consider transit improvement needs.
- Review the Town design standards and ensure that preliminary designs/concepts follow the standard requirements.
- Be familiar with Town checklists and templates.
- Perform engineering, drainage, operations, maintenance, and utility related reviews.
- Provide engineering review of the initial tentative map. (Additional map work may be assigned at a later date).
