- July 7, 2021 Town Council direction to seek out additional housing programs/MLH collaboration items
- New programs:
 - "Bridge" Program buy market rate condos, deed restrict and sell
 - New grant sources HomeKey
- Town Council desire to identify priority focus areas for 22/23 contract
- Joint meeting Wednesday, February 9 at 5:30 p.m.

Potential Focus Areas

- Creation and preservation of deed restricted units
 - Use Revolving Loan Fund (RLF) to preserve deed restricted units
 - Use the Town "Bridge" program to add new units
 - Define funding programs to add affordable deed restricted units (e.g., HomeKey)
- Develop and maintain a proactive wait list for renters/owners
 - Match households with appropriate housing units
 - Consider affordability level, family size, rental, ownership etc.

Potential Focus Areas

- Seek out and apply for grants to bring more money to produce new housing units in Mammoth Lakes
 - Traditional funding sources like CDBG, HOME
 - Non-traditional sources (e.g., Community Reinvestment Act (CRA)),
 - Provide options to maximize federal, state and other funding sources.
 - Actively manage, report, track and promote grant funding

Potential Focus Areas

- Provide Real Estate Services
 - Buy and sell units for the Bridge Program
- Provide housing services and information to community members
 - Office hours
 - Website
 - 'Housing ambassadors' or 'ombudsmen' to increase capacity

Next Steps for MLH Contract

- February 9, 2022 Joint Meeting with MLH Board
- Draft MLH contract to Town Council by May 7
- Final Contract on June 1

Other meetings as needed?


Other Items

- MLH operates as a legislative body due to Councilmember/BOS appointments
- MLH could transition to a stand alone non-profit if desirable
- MLH CHDO status limits elected official involvement but provides additional funding opportunities
- If directed by Council, staff can analyze changes to the relationship structure
