a digital format. Edit the video into evergreen stories so it can be used as archive programming on the local channel.

The Mammoth Channel is an established local cable channel that currently runs a continuous loop of programming on Suddenlink Cable Channel 12.

There are at least 4 formats of analog tape to transferred. 3/4", Hi8, VHS and DVCam.

There is not any fast way to do the transfer. It will take real time,

Re: One Hour tape, One Hour transfer time.

There are an estimated 1,000 tapes, or more ...

Logging tapes average 2 hrs per 1hr of video.

Editing time varies but on average 1hr editing time per 1 minute of programming.

All of the video needs to be edited and exported into a viewable file.

Exporting tapes to the cloud for storage takes real time.
