Program Description and Purpose	IGNITE's inclusive (welcoming of people of all backgrounds and abilities) recreation program will develop and implement opportunities for

people with disabilities, their families, and community members to engage in meaningful outdoor recreation experiences. Our track record in this area began in 2013, with the founding of IGNITE. Since that time we have incorporated sustainable, no-cost outdoor recreation opportunities in Ventura County, Los Angeles County, and the Eastern Sierra including trail adoption, an annual backpacking trip, weekly and monthly hikes, indoor rock climbing, annual summer programs, beach cleanup days, and camping trips. In Mammoth Lakes we have hosted ski weekends in collaboration with Disabled Sports Eastern Sierra and have helped people with disabilities access rock climbing, stand up paddleboarding, camping, fishing, hiking, and other outdoor activities. We work to make these opportunities as accessible as possible, both physically and financially.

The purpose of this program is to introduce inclusive outdoor recreation opportunities to people with disabilities, their families, and community members. We will teach the physical skills needed for accessing these opportunities, including adaptations as needed (e.g., adaptive equipment, trained support people, etc.), along with cultivating the values of environmental stewardship and sustainability. We will also provide healthy meals and snacks for participants, taking into account individual dietary needs.

Our team includes people with vast outdoor experience and who are CPR and Wilderness First Aid certified, family members, and an educator with experience creating and...

... implementing curricula.

Making this opportunity available to both local residents and visitors will create connections across geographic areas and will encourage visitors to choose Mammoth Lakes when making future travel plans. Visitors will bolster the local economy by paying for lodging, groceries, restaurants, and other activities. We will encourage visitors to engage in additional recreational opportunities including and not limited to the movie theater, axe throwing venue, bowling alley, breweries, museums, art galleries, and other resources.

At least two of the three paid staff positions will go to people who live in the Town of Mammoth Lakes, and local outreach will be done via social media, e-newsletters, personal contacts, and collaborations with Disabled Sports Eastern Sierra, Volunteer Eastern Sierra, and other community organizations. We will also happily welcome local and visiting volunteers.

From July 2022 through June 2023 will offer fifteen (15) full days of inclusive outdoor recreation programming for people with disabilities, their families, and community members. Program Description and Purpose	The Valentine Eastern Sierra Reserve's Outdoor Science Education Program provides nature- based outdoor education for thousands of children each year. Our programs focus on getting kids outside, where they learn about nature, art, Indigenous culture and how to responsibly recreate and become stewards of the land and waters around them. The Valentine Eastern Sierra Reserves are part of the University of California's Natural Reserve System and operated by the University of California, Santa Barbara. The programs are place-based at

the two University of California Reserves in Mammoth Lakes (SNARL and Valentine Camp), encompassing montane forests and Great Basin ecosystems. All learning takes place outdoors and activities for different grade levels focus on nature-based knowledge and awareness through the lenses of art, traditional ecological knowledge and exploration. Our program aims to deepen the public understanding and appreciation of the Eastern Sierra and foster continued environmental stewardship of this ecologically and economically important region.

Children of all backgrounds and ages benefit from time spent outside exploring and learning. Nature-based education provides an engaging context for learning, and gives children the tools they need to feel comfortable in the outdoors and to be able to recreate responsibly. Direct observation of organisms and the environment is a profoundly moving, even transformative experience, and one that is not often accessible in classrooms. When students look closely at a part of the natural world–like a leaf or a salamander–then ask questions or form explanations from their observations, they fall a little in love with it. They cultivate a...

... relationship with and deeper understanding of the natural world. These experiences are common to nearly every naturalist and are essential building blocks of both environmental literacy and stewardship.

The main purpose of the Outdoor Science Education Program is to promote environmental literacy and stewardship by providing opportunities for students to engage directly with nature and explore the world around them. This

is particularly important in this remote region of California, where the population generally has limited access to cultural and academic enrichment activities. Mono County is a large, but sparsely populated region of the state. Many students from this area come from culturally diverse backgrounds (namely Hispanic) that are underrepresented in the environmental sciences. Our field trip programs engage students from across these diverse backgrounds in the outdoors, and the classroom activities that support or follow the field experiences link this program to the formal educational setting. We have aligned all of our teaching activities with the Next Generation Science Standards and continue to work with the local school districts to support the in-school curriculum.

Importantly our programs focus on appreciation and understanding of nature. Art, including painting, photography, music and other forms of creative expression are central to many of our programs. Others focus on outdoor skills including hiking, navigation, and map reading providing readiness for children to engage in a lifetime of outdoor recreation.

Recently our program has been chosen to participate in a 2-year study funded by the National Science Foundation, which is focuses building capacity to foster equitable, ...

...inclusive, and culturally relevant work environments for outdoor science organizations. The Working Towards Racial Equity Project (http://beetlesproject.org/wtre-spring-cohort/) focuses on ways for environmental and outdoor organizations to be more inclusive and enhance the participation of traditionally underrepresented

communities in the outdoors and environmental sciences. We recognize that there are many barriers to fully engaging diverse participation, and one of our primary goals in the coming years is to try to eliminate some of these barriers, and provide a more welcoming and inclusive environment. We recognize that many children in the Mammoth Lakes community are English language learners, and many families in the area are socio-economically disadvantaged.

We propose to recruit an additional bilingual (Spanish-English) teacher for our program who can develop additional dual language classes, provide appropriate translations for teaching materials, and increase engagement with our local Mammoth Lakes LatinX community. We aim to remove financial barriers for any families in need, and we would like to expand the number of scholarships that we offer to local Mammoth families for our summer programs so that we can increase the participation of children from disadvantaged families.

Program details (timeline, dates, schedule, venue, etc.)

The VESR Outdoor Science Education Program was started in 1995 by Leslie Dawson, a former park ranger and school teacher. She recognized the lack of museums and other cultural opportunities in the largely rural Mammoth Lakes area, and wanted to be able to provide children with learning opportunities outside of the classroom. As the spouse of Dan Dawson, the former Director of the Valentine Eastern Sierra Reserves, she immediately recognized the potential for outdoor learning opportunities at the two reserve sites. The program started out with a few field trips from local schools, and over time has grown into a larger program that provides access to – and an opportunity to appreciate

nature to thousands of children each year. The program is divided into schoolyear field trips and weeklong summer 'camps'.

Schoolyear Field trips - September to May -These are free one-day field trip programs to the Valentine Camp Reserve and SNARL for K-6 students in Inyo and Mono Counties and beyond. These field trips offer students the ability to get outdoors and engage in nature learning. These programs provide age-appropriate, field-based learning opportunities at both SNARL and Valentine Camp for approximately 2000 students in spring and fall of each year. Classes come to the reserves for these field trips from 4-8 schools in several different school districts. The regional schools and the Reserve teaching staff have aligned their curricula, and the field trips include age-appropriate lessons and activities at the reserves. Some typical lessons are ant ecology with ant tracking and food preference experiments; archaeology and introduction to Indigenous cultural practices ranging from rope making to hunting techniques, forest mammals ...

...(with skulls and furs); and forest fire ecology. Many lessons include simulation games, route finding, and artistic expression.

Summer 'Camps' - June to August – These are weeklong summer 'camp' programs at Valentine Camp and SNARL that focus on engaging children in outdoor activities ranging from art to navigation to Indigenous cultural practices and beyond. The summer programs are open to local children as well as those of summertime visitors to the Mammoth Lakes area. Younger students combine art and outdoor exploration with the study of habitats, insects, bats, or trees, while the

older students may learn about Indigenous cultures, photography, natural history, forest ecology, or practice nature-based art. Several programs are bi-lingual (Spanish-English). Tuition for these programs is based on a sliding scale dependent upon income, and we try to offer scholarships to any families that cannot afford to participate.

Through the COVID pandemic we continued to work with our local school districts and communities to provide virtual learning experiences and virtual field trips. We have recognized the extremely urgent need right now to get kids outside, and to re-gain important emotional, and physical connections to nature and the outdoors. We promote our program through the local school districts, and distribute information on our summer programs through the local schools as well as through the Mono County and Mammoth Lakes offices of recreation and tourism. Our programs are featured on our VESR website and we mail and email information on our summer programs to a broad local and regional email and mailing list. Our programs are supported entirely on funding through gifts, grants and volunteer effort. The...

... schoolyear programs are entirely free, and we make every effort to ensure that there are no financial barriers to participation in our summer camps for children from disadvantaged families.

Our program funding request is directly aligned with all of the Mammoth Lakes Recreation Guiding Principles.

Quality of Life – Outdoor learning and recreation are fundamental to quality of life in the Eastern Sierra. Exposing children to the love of nature and the outdoors at an early age, will enhance their lifetime appreciation and enjoyment of the outdoors. Time in nature is linked with overall mental, physical and emotional health and wellness benefits. Diverse educational experiences at an early age leads to greater educational outcomes later in life, and a wider array of career options.

Public Benefit – Our programs benefit every child in Mono and Inyo counties and parts of Western Nevada. We reach thousands of schoolchildren each through our field trip programs. These are not one-time visits, but they return to both reserve sites each year in every grade from K to 6th grade for an array of unique and grade specific programs. Our summer programs also include children from families visiting the Mammoth Lakes area in summer. We specifically aim to make our programs accessible to all families regardless of their income, language,

physical, mental or emotional abilities.

Sustainability – Our programs center on nature and the outdoors, and sustainability lies at the heart of the mission of our organization. Economic, social and environmental sustainability are all important elements of our success. The Outdoor Science Program has operated since 1995 through facilities and lands managed by the University of CA, providing for long-term stability. We have been able to sustain the core operations of the program through donor

... support and volunteers who are all deeply committed to the overall program moving forward. Our programs are beloved in the community, and we are now teaching the next generation, kids of kids, who have been through our programs. Environmental sustainability is a one of VESR's key strategic goals, and the reserves have implemented many projects over the years (photovoltaic systems, solar hot water, recycling, etc.) that have drastically decreased energy demands, and reduced the consumption of waste and other resources. We regularly highlight these projects in our programs in an effort to inspire and educate our students and community members about how they can contribute to sustainability in their everyday lives.

Stewardship – Stewardship is at the heart of our mission (to advance knowledge and promote stewardship of the Eastern Sierra region through science, education and public engagement) and is inspiring environmental stewardship a key objective of the Outdoor Science Education Program. As children are exposed to nature at early age, they develop and deepen their

	understanding and appreciation of the outdoors, and there is a wide array of research demonstrating how outdoor and environmental programs for children can lead to strong stewardship attitudes and behaviors throughout a lifetime.

Program Description and Purpose	The scope of application for the Mammoth Lakes TA is four-fold; providing an additional professional presence on the trails in

collaboration with the USFS and MLTPA to educate visitors on LNT and wilderness ethics, offering educational interpretive programs on the many "ologies" of the Eastern Sierra, being another set of capable hands when it comes to trail restoration and maintenance, and organizing volunteer opportunities for visitors and locals alike. Since 2017, Friends of the Inyo has engaged over 600 volunteers in 2579 hours of service, lead 248 guests on interpretive hikes, maintained 742,000 feet of trail, removed 352 logs, cleaned 424 campsites, restored 118 illegal campsites, obliterated 389 illegal fire rings, removed 2,552 pounds of trash, and made 8,446 visitor contacts on Eastern Sierra Forest Service lands, from Lone Pine to Bridgeport. A crucial component of this region-wide program is the Mammoth Lakes TA: a professional presence dedicated to stewarding solely the Mammoth Lakes Trail System. As one of the Eastern Sierra's primary recreation destinations, Mammoth Lakes' burgeoning visitation warrants extra management. The aim of this TA is to provide an additional presence to take care of trails and meet users where they are: at the trailheads, on the trails, and in the backcountry.

Strong local partnerships:

Friends of the Inyo has a long history of stewardship and educational accomplishments on the Mammoth Lakes Trail System. We have established lasting partnerships with the Town of Mammoth Lakes, Mammoth Lakes Recreation, Mammoth Lakes Trails and Public Access, and the Inyo National Forest. Our TA program has...

... worked alongside TOML and MLTPA trails staff since 2014, and we look forward to

continuing to do so. To ensure the program's successful integration with other efforts to care for the Mammoth Lakes Trail System, we will regularly discuss schedules and proposed projects with the Trails Coordinator, the Inyo National Forest, and Mammoth Lakes Trails and Public Access.

Interpretation programs on the Mammoth Lakes Trail System:

A primary goal of the Mammoth Lakes TA program is to share the stories of our region's natural and cultural history. From June through September 2022, the Mammoth Lakes TA will lead monthly interpretive walks, engaging a group of 15 participants (considering Covid-19, we have decided to cap participation at 15) on topics ranging from geologic history to ethnobotanical uses of native plants. Interpretive programs give visitors a deeper understanding of the Mammoth Lakes Trail System's rich ecology and culture. This knowledge evolves into proud stewardship of the area and a greater connection to place for visitors.

Trail Maintenance and Restoration:

The TA will be professionally trained and certified to USFS standards on how to perform vital maintenance on popular trails within the Town of Mammoth Lakes, removing fallen trees, cleaning water bars, and repairing rock steps. In 2021, the Mammoth Lakes TA made 309 visitor contacts while out on the trail, monitored 130 miles (one way) of the Mammoth Lakes trail network, removed 22 downed logs, removed 280 pounds of trash, and removed 26 illegal fire-rings. Without this work, many popular trails would have remained inaccessible or unsafe. Regular

maintenance...

... increases the sustainability of the Mammoth Lakes Trail System and dramatically reduces the likelihood of catastrophic trail failures and costly large-scale repairs.

The Mammoth Lakes TA will maintain or patrol all Forest Service system foot trails accessible from the Town of Mammoth Lakes, remaining within the Mono County boundary and the Town of Mammoth Lakes Sphere of Influence. During regular trail patrols, the Mammoth Lakes TA will make contact with trail users, sharing information about trail conditions, fire restrictions, safety, Leave No Trace principles, and wilderness ethics. Visitors who encounter this information while recreating on the Mammoth Lakes Trail System are more likely to become good stewards themselves.

Volunteer Opportunities:

In addition to professional trail work, the Mammoth Lakes TA will lead volunteers in stewardship projects. These projects will include at least one volunteer community stewardship cleanup event at a location designated within the Mammoth Lakes Sphere of Influence (Garnering as many as 40+ volunteers), and a more immersive volunteer "Work Week" proposed for Valentine Lake, where up to 10 volunteers backpack and camp at a remote location in need of more extensive maintenance. Additional collaborations on other "Trail Work Days" may be requested by Mammoth Lakes Trails and Public Access. The TA will also lead personalized service projects for visiting youth groups from urban areas. These volunteer stewardship events will generate over 150 hours of service

(valued at \$4,200) and will enrich participants' experience of the Mammoth Lakes Trail System by creating a sense of investment in and...

... responsibility for our public lands.

As our region's primary outdoor recreation destination, Mammoth Lakes hosts a vibrant local community and draws visitors from around the world. The Mammoth Lakes TA will provide that community with unique, meaningful opportunities to care for, and give back to the trails they love.

Last season (2021) the Mammoth Lakes TAs were able to dedicate 2-3 days of work each week to the Mammoth Lakes Basin, this year we hope to be able to expand the program to full time (40hr/week). The season usually starts in May and typically runs until September, depending on weather and fire conditions. The TAs worked closely with the USFS Mammoth Lakes Ranger District and the Town of Mammoth Lakes' trail crews interacting with visitors, maintaining trails, cleaning campsites, leading interpretive hikes, and providing Leave No Trace education. The Totals for the two TAs' time spent in Mammoth Lakes are: Hours spent on trail: 306 Visitor contacts: 287 Pounds of trash removed: 148 Fire rings removed: 25 Logs removed from trail: 17 Miles of trail monitored: 103mi with 3580 ft of trail maintained Interpretive Hikes guided: 3 (one canceled due to air quality) 2 volunteer cleanup events held: with 22 volunteers

All program offerings are contingent upon approval from the USFS and MLTPA and therefore have yet to receive date confirmation. Should a proposed project not receive approval, we have backup programs waiting in the wings. All proposed events in previous years were approved, and we have no reason to believe this season will be different.

This upcoming 2022 season will see even more volunteer events within the Mammoth Lakes Sphere of Influence. As mentioned above, we propose a "Work Week" event held for the Valentine Lake trail, which is in need of extensive repair and maintenance due to trail erosion ...

...and social shortcuts that lead hikers off trail. The date is TBD by the USFS.

This year again, we will offer interactive cleanup events in the Lakes Basin, both–open to the public stewardship events, and private events held in partnership with the local youth groups such as Rustic Pathways, whose participants come from around the world. The dates for these volunteer days are also TBD contingent upon collaborative Youth Groups and USFS.

A staple of every TA's season is developing and delivering their own interpretive program specific to the ranger district they work in. The Mammoth Lakes TA will provide a once-monthly hike and educational program on a topic of their choosing running on weekend days from June through September, open to the public and free of cost.

Program Description and Purpose	The purpose of this program is to deliver avalanche information to backcountry users in the Mammoth Basin in the form of regularly issued Avalanche Advisories, educational opportunities and events during the winter season, and public outreach to make direct contact with winter users in the Mammoth Basin.
Program details (timeline, dates, schedule, venue, etc.)	Between the months of December-April ESAC will issue daily avalanche advisories for the Mammoth Basin and wider Eastern Sierra. In the early and late seasons, snowpack summaries with no danger rating are provided for backcountry users. We intend to issue avalanche advisories seven days a week for the heart of the

winter season. ESAC maintains a website to distribute these advisories to the public, at no cost to users. Members of the public may subscribe to the website and receive daily emails that contain avalanche advisories at no cost to the user.

ESAC plans to hold a season kick-off event in the early season of the 2022/23 season with a full day of free avalanche education workshops and seminars. The organization will host four avalanche awareness education evening events throughout the winter season, one each month, December through March. These will occur at local venues in Mammoth Lakes, and surrounding towns in the Eastern Sierra. All events will be streamed virtually on Zoom, recorded, and archived for public viewing free of charge on the ESAC website.

ESAC will host an annual Interagency Roundtable event in January as an informative space for local agencies and organizations that are affected in some way by avalanches.

Additionally, ESAC will host a free volunteer observer training day for key observers in the early winter season where qualified volunteer observers are invited into the field to practice and standardize snowpack observation techniques so they may contribute snowpack and avalanche observations which are published on the ESAC website. This will be a field based training...

... that will occur in the Mammoth Basin.

For the 2022/23 season ESAC will continue with a public outreach campaign, including a social

media campaign, to promote ESAC safety resources and engage winter users in the Mammoth Basin. This includes educating Mammoth Basin trailhead hosts and providing backcountry travelers with avalanche awareness and safe travel informative materials for distribution at trailheads. ESAC is broadening its educational reach and additionally targeting winter OHV users to provide OHV specific avalanche awareness and education.

ESAC will employ three avalanche forecasters as employees, two part-time administrative staff, and two professional observers. All employees will work from home and in the field, there is no in-person office space.

Program Description and Purpose	Chamber Music Unbound's (CMU) year-round programs serve the Mammoth Lakes community as a whole; from students and young families, to retirees and visitors. CMU programs are in four categories:
	 The Unbound Chamber Music Festival (UCMF) with the concurrent Sierra Academy of Music (SAM) and Sierra Chamber Ensemble Workshop (SCEW) is a Classical music festival

in the tradition of the great American summer mountain festivals such as Aspen and Taos. The UCMF brings together renowned performing artists and talented music students from around the globe in our beautiful mountain setting, establishing Mammoth Lakes as a cultural tourism destination. Nine ticketed concerts are open to the general public and typically sell-out. Additional free student performances take place almost daily. Every year, the most dedicated local students have the unique opportunity to participate and continue to develop their skills over the summer with the help of some of the world's best teachers and performers.

2. The Felici & Friends Winter Concert Series is a six-event series of professionally performed chamber music in ticketed concerts with the resident Felici Piano Trio and esteemed guests. The series surveys the repertoire for small ensembles ranging from the Baroque to contemporary music in an eclectic mix of old and new. The concerts are widely-advertised and open to the public for a ticket price well under the average of comparable series, as our full-time residents' median income is well below the California average. The art form of chamber music (music for a small group of players, with each player performing their own part) is uniquely suited to contribute to community building, as it can transcend the boundaries of ...

...language, geography, race, religion, gender, age, and politics. Because it uses only musical sound with no words or lyrics, classical chamber music has retained its relevance for individual listeners as much as for society as a whole, because it reflects and encapsulates values that represent the foundations of Western

democracy.

3. "Young People's Concerts" for MUSD students have been ongoing since 1998, the first season of the Felici Piano Trio in Mammoth. The Felicis and guest artists perform a series of 20 concerts each year that are organized and presented in collaboration with the Mammoth Lakes Friends of the Library, MES PTO, MMS PTO, MHS Band Program, and the County of Mono. "YPC" are designed to engage different age groups and help students forge intellectual, spiritual, and emotional connections to music as art. The liveconcert experience opens doors to far-away places and long-gone times, but also addresses students' spiritual needs in the here and now, because it enables young listeners to derive personal value and communal meaning from the artistic experience. The goal of "YPC" is to awaken and nurture the love and understanding of music in every young person and through the music communicate value-based life lessons. The concepts of individuality and society and their healthy interaction are discussed in the context of students' own experiences in the realm of friendship, family, sports, visual arts, drama and dance. The music itself, as well as the story-telling context in which it is presented, stimulate students' imaginations and create contemplative space, in which learning and reflection can flourish. "YPC" allow students to develop a degree of musical literacy and deepen their...

... sense of artistic perception as they learn to describe the basic elements of music. Their understanding of musical processes is furthered through active participation: singing, clapping, acting out melodic gestures and imitating

dynamics, in playful interaction with the artistteachers. For many students, experiencing such a concert is their first encounter with art music, and the spark that motivates them to learn to play an instrument themselves.

4. CMU Community Music School offers affordable high-quality after-school music education programs to local residents of all ages and skill levels. To address the entire Mammoth community, sign-ups for group lessons are announced through a bilingual flyer and the MES newsletter, and ongoing communication with parents is facilitated in English and Spanish. Almost all of the participants receive financial aid, either in the form of tuition scholarships, low cost rentals or free loaner instruments. The music school focuses on instruction of string instruments and piano and thus supplements MUSD's band and choir programs. Emphasis is on the collaborative aspect of music making and development of team spirit. A variety of styles, including jazz, folk and popular, are explored in the music chosen for these groups, and the most successful students will gain the skills to join the community orchestra, which performs standard Classical and Pops repertoire. This year, over 70 young local musicians are enrolled in CMU Community Music School.

Program details (timeline, dates, schedule, venue, etc.)

Unbound Chamber Music Festival. The threeweek festival takes place from mid-July until the beginning of August at Cerro Coso Community College (CCCC) in Mammoth Lakes. The concerts and free performances take place in the lobby, which is converted into a 220-seat concert hall, and the academy/workshop activities, such as lessons, rehearsals, coachings are in the various classrooms. In addition, there are free

concerts and daily masterclass performances by student performers, as part of the concurrent Sierra Academy of Music and Sierra Chamber Music Workshop.

Felici & Friends Winter Concert Season. The Felici Piano Trio's winter season has been inplace since the ensemble moved to Mammoth Lakes on a NEA grant in 1998 and runs from September through May. The concerts take place either at CCCC or at the Mammoth Lakes Lutheran Church.

"Young Peoples Concerts" take place throughout the academic year. About 20 separate performances take place during the academic year at the ML Library, CCCC, and at MUSD school sites. Dates and venues are coordinated with the administrative offices at each school site, as well as MUSD music teacher, Michael Hammers. Typically there is one set of concerts for TK-2 grade students in collaboration with the library in the fall, a set for MMS students at Cerro Coso in early spring, a set for all MES grades in April and several performances throughout the year, with guest artists at MHS. Some years we receive special requests from pre-school programs or other programs, which we honor as schedules allow.

CMU Community Music School. All music education programs through the community music school are aligned with MUSD's...

... academic year which runs from mid-August through mid-June. Weekly after-school music lessons for individuals (Mondays, Thursdays and Fridays), group lessons (Mondays and Wednesdays), chamber music coachings (by

appointment), and orchestra (Tuesday evenings); these programs are offered in collaboration with MUSD on school sites (groups) and Cerro Coso College (orchestra). Over 70 Mammoth students are currently enrolled; the school presents 4 free and open to the public student concerts/recitals per year at Cerro Coso and St. Joseph's Church.

Additionally, MAC's adult programs, including Art & Wine, the Gallery & Community Arts Center, and the Mammoth Lakes Arts on the 4th Festival are essential components that help MAC raise

money and awareness for arts education and support local artists by giving them a place to showcase their talents.

Program Description and Purpose

With support from the Town of Mammoth Lakes and Measure U Grant Funds, Mono Arts Council intends to expand both its in school and afterschool arts programs for the children of Mammoth Lakes and continue its summer Kids Art Camps for both locals and visitors. MAC will start thevyear off with our Summer Art Camps. For half of our camps, MAC will be partnering with the Town of Mammoth Lakes Parks & Rec. Department to provide Summer Art Camps in Mammoth Lakes. Please note, these Parks & Rec camps will not need funding from Measure U.

The 2022 camps offered will be: Photography & Adventures in Art. We will also be offering a three day mosaics camp and a 5 day dance camp at the Mammoth Lakes Community Center, not in partnership with Parks and Rec. Each camp will not only provide a deeper exploration of the artistic expression learned but also an opportunity to connect art with the culture and nature of the community.

Our next programs are both our in-school and after-school arts programs. We will continue with our Create With the Greats program (previously Meet the Masters). We have modified this program to create our own program materials featuring Master Artists that are more relevant to

our students. As before, all students at Mammoth Elementary School and Mammoth Middle School, Kindergarten - 8th grade, are visited by Mono Arts Council Teaching Artists 5 times throughout the school year to learn about a Master Artist. Each lesson contains about 15-20 minutes of art history with images of art created by the Master Artist then the rest of the hour students are guided...

... through an art lesson based on the work of the master artist. Students are encouraged to create rather than replicate during the lesson. We will also be adding an in-school K-12 Dance program. During the 2021/2022 school year, we started a program at Mammoth Middle School called Dance Appreciation. This program happens during the History Class twice a moth, where students are taught about the historical and cultural importance of dance through the decades. We plan to continue the program at MMS and teach a version of this program at both MES and MHS. This will be the first time for a sequential dance program at any Mammoth School. We are also planning to develop a Cultural Arts Program to start during the 2023/ 2024 school year. This program will be offered for 4th-12th grade and be an opportunity for students to learn performing and visual arts of a different culture each school year. Our plan is to start with either our Native American Culture or a Latin American Culture.

Following the in-school arts programs will be our expanded after-school arts program. The After-School Art Club in Mammoth will be a weekly club starting in September and ending in May with a rotation of learning in visual art, theatre, and dance. We would like to host these classes at the MAC Gallery & Art We will a students Dependi art-clubs

Center, however, we may partner with the Mammoth Elementary and Mammoth Middle School to provide better access to these programs if attendance is low at our MAC space. The programs will be open to children ages 5 – 17 and will provide students the opportunity to express themselves artistically in a safe ...

...and nurturing environment. We will also be providing after-school art to the students of Husky club twice a month. Depending on the success of these after-school art-clubs, we may expand any one of the arts mediums to provide a more in-depth training for the students.

Kids Summer Art Camp:

January - March MAC Admin staff meets with teaching artists to develop program for the coming summer and contacts venues to start confirming dates.

March/April MAC Admin staff works with graphic designer to add program information and class sign up system to website. MAC staff attends Mammoth Lakes Summer Recreation Expo to recruit local attendees for camps.

April-June MAC Admin staff and teaching artists plan and order supplies for various camps.

Camps take place during the month of July, possibly the first week of August each year. Each camp will be 3-5 days long, depending on the subject of the camp. Some camps will take place at the Mammoth Lakes Community Center and the camps in Partnership with Parks & Rec will occur at Shady Rest.

Create With the Greats:

July-August MAC Admin staff determines the Master Artist lessons for the year. Teaching Artists are contacted to determine availability and art supplies for the first lesson are ordered. August-September MAC Admin staff and teaching artists coordinate with school admins for letters of agreement and begin scheduling lessons with classroom teachers. September/October - April/May MAC Admin staff and teaching artists work together in ordering supplies, scheduling classes, and going into the classroom to present the lessons.

March - MAC Admin staff works with school admin to schedule exhibit for art from the program.

... classroom teachers. MAC Dance Program July-August MAC Admin staff meets with teaching artist to review lessons for the year. August-September MAC Admin staff and teaching artists coordinate with school admins for letters of agreement and begin scheduling lessons with classroom teachers. September/October - April/May MAC Admin staff and teaching artists work together in ordering supplies, scheduling classes, and going into the classroom to present the lessons. artists for program. Once TAs have been identified, interviewed, hired, and processed, MAC Admin staff works with TAs on program development and schedule for the first semester and/or year of classes. MAC Admin staff secures appropriate classroom space for each activity. August/September MAC Admin staff works with graphic designer to add class information to website and develop informational flyers. September/October - May/June MAC Admin staff and teaching artists work together in ordering supplies and presenting the lessons. If there are performing arts classes taught, there will be an opportunity to perform at the end of each semester (December & May).
