### **RECOMMENDATION:**

Receive final report on SNC Grant 1148-RT and provide comments.

### **BACKGROUND:**

The Town was the lead agency for a \$618,750 Sierra Nevada Conservancy Grant under the category of Sustainable Recreation and Tourism awarded in June 2019. The work under the grant represented a regional approach to defining priorities and means of enhancing sustainable recreation an recognizing the linkage to the region's tourism-based economy. The grant was developed around four work categories plus general project management and grant administration. The work categories included:

- 1. Regional Recreation Stakeholder Engagement,
- 2. Climate Adaptation and Resilience Assessment,
- 3. Connection to the Eastern Sierra Visitor Audience; and
- 4. Project Development and Prioritization.

The first three categories built upon each other to lay a foundation to work through a community generate list of potential projects. The final step was to identify a final eight projects to pursue funding for implementation. The larger project list was refined into a portfolio of projects which may be accessed in the future as a potential guide for pursuing additional projects by the stakeholders, out of the 220+/- ideas generated. The grant work is nearing completion with only final reporting and billing remaining.

Numerous meetings and presentations were made throughout the grant funded project to stakeholders, local agencies and to the Eastern Sierra Sustainable Recreation Partnership meetings. A high level of public outreach was an important part of the grant process. A brief overview of grant process and key work areas follows. A more detailed presentation will be presented to Council as part of the final report.
