Minutes of Regular Meeting

January 18, 2023, 4:00 p.m. 437 Old Mammoth Road, Suite Z, Mammoth Lakes

1. CALL TO ORDER

The Mayor called the meeting to order at 4:02 p.m. in the Council Chamber, 437 Old Mammoth Road, Suite Z, Mammoth Lakes.

2. PLEDGE OF ALLEGIANCE

Acting Police Chief Dan Casabian led the flag salute.

3. PUBLIC COMMENTS

Cheryl Wilson spoke about an issue with too many people and too many cars at a transient rental unit near her.

Brandon Brocia, owner of The Eatery, spoke about the Town adopting plastic waste reduction regulations.

Councilmember Rea arrived at 4:06 p.m.

Councilmember Rea announced that tomorrow at 5:30 p.m. the Mammoth Community Water District would be voting on wastewater testing for infectious disease.

Town Manager Daniel C. Holler introduced Acting Police Chief Dan Casabian to the Council and the community.
