RESOLUTION NO. 23-23

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MAMMOTH LAKES, STATE OF CALIFORNIA, DECLARING ITS INTENTION TO MODIFY THE MANAGEMENT DISTRICT PLAN OF THE MAMMOTH LAKES TOURISM BUSINESS IMPROVEMENT DISTRICT

WHEREAS, the Town Council of the Town of Mammoth Lakes initially created the Mammoth Lakes Tourism Business Improvement District (MLTBID) in 2013; and

WHEREAS, on June 6, 2018, the Town Council adopted Resolution No. 2018-37 renewing the MLTBID for a five (5) year term; and

WHEREAS, the Property and Business Improvement District Law of 1994, Streets and Highways Code §36600 et seq., allows the Town to modify the Management District Plan (MDP) at the request of the Owners' Association; and

WHEREAS, the MLTBID Owners' Association, Mammoth Lakes Tourism, has requested modification of the MDP.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL THAT:

- 1. The recitals set forth herein are true and correct.
- 2. The Town Council declares its intention to modify the MLTBID MDP.
- 3. The proposed modification of the MLTBID MDP will modify the authorized expenditures to be funded with the revenue derived from the levy of the assessments, in order to be consistent with the authorized expenditures proposed for the upcoming renewal of the MLTBID.
- 4. The time and place for a public hearing on the modification of the MLTBID MDP are set for April 19, 2023 at 4:00 PM, or as soon thereafter as the matter may be heard, at the Council Chambers located at 437 Old Mammoth Road, Suite Z, Mammoth Lakes, CA 93546.
- 5. This resolution shall take effect immediately upon its adoption by the Town Council.
