RESOLUTION NO. 25 -

RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MAMMOTH LAKES, STATE OF CALIFORNIA, AUTHORIZING THE TEMPORARY CLOSURE OF CERTAIN TOWN ROADS FOR THE FOURTH OF JULY PARADE AND FREEDOM MILE RUN ON JULY 4, 2025

WHEREAS, the Town of Mammoth Lakes desires to work with the private sector in the implementation of special events that increase visitation to the community; and

WHEREAS, the Fourth of July Parade and the Freedom Mile Run will enhance the quality of life for residents and promote visitation of Mammoth Lakes; and

WHEREAS, the temporary Town road closures will enhance public event safety and provide for emergency access to and through the events; and

WHEREAS, a portion of proceeds from the Freedom Mile will be donated to local non-profit organizations for charitable uses.

NOW, THEREFORE, BE IT RESOLVED that the Town Council of the Town of Mammoth Lakes, California, hereby:

- 1. Declares the program is not a project and is exempt from the California Environmental Quality Act because it is a minor temporary use of land having negligible or no permanent effects on the environment per Section 15304 (e); and
- 2. Declares that the south side of Chateau Road, from Old Mammoth Road to Minaret Road, will be closed from 2pm on Thursday, July 3 to 11:30am on Friday, July 4; and
- 3. Declares that the west side of Azimuth Drive, from Chateau Road to Meridian Boulevard, will be closed from 2pm on Thursday, July 3 to 11:30am on Friday, July 4; and
- 4. Declares that Azimuth Drive will be closed on Friday, July 4 between Meridian Blvd. and Chateau Road from 9:00am-11:30am, when all traffic control devices will be removed; and
- 5. Declares that Chateau Road will be closed on Friday, July 4 between Minaret Road and Old Mammoth Road from 9:00am-11:30am, when all traffic control devices will be removed; and
- 6. Declares that Old Mammoth Road will be closed on Friday, July 4 from Minaret Road to the intersection of Sierra Blvd. and Main Street from 10:00am-1:00pm, when all traffic control devices will be removed; and
- 7. Declares there is a public benefit; and
- 8. Authorizes 'no parking' and traffic control equipment to be placed along the street prior to the event; and
- 9. Directs the Mammoth Lakes Police Department (MLPD) and Public Works Department to monitor the traffic within the event area and make any modifications that are deemed necessary for public safety.
