A. PROJECT DESCRIPTION AND BACKGROUND INFORMATION

Triad/Holmes Associates will provide materials testing and inspection services during the construction of the MACC. The testing and inspection services will be performed by Sierra Geotechnical Services, Inc (SGSI) who will be a sub-consultant to Triad.

B. SCOPE OF SERVICES

- Provide field and laboratory testing and inspection services in accordance with the project plans and specifications, including but not limited to the following:
 - Daily Inspection Reports (DIRs) and Final Report
 - Concrete, grout and mortar
 - Building pad, foundations, trenching and other site work
 - Hot mix asphalt (HMA)
 - Welding, bolting, rebar, anchors, fire proofing
- Rates will abide by prevailing wage and the attached SGSI proposal (Exhibit B).
- Tests and inspections not included in this scope will be charged according to the 2024 schedule of fees (Exhibit B).

The Town and the Contractor (Spiess Construction Co., Inc.) will coordinate with Triad and SGSI for scheduling the services. The Contractor will provide safe and adequate access to perform the testing and inspection.
